



Shut down a law firm

The Monson Law Firm successfully uncovered improper attorney solicitation of clients through the use of unlicensed public adjusters after Hurricane Isaac. After filing complaints with the Louisiana Bar Association, the managing lawyer of the Louisiana office quit and remaining members were let go. As a result of our hard work, the law firm closed its office and transferred over 400 files to another firm.

Took \$76,000 from a public adjuster

The Monson Law Firm determined that one of Louisiana's most notorious public adjusters deposited a \$76,000.00 Coverage A check into his account. Our investigation revealed that the check contained a fraudulent mortgage company endorsement. Working closely with the mortgage company, the public adjuster's bank account was frozen and all funds were returned to the carrier.



Punished engineer

In response to a complaint filed by The Monson Law Firm, the Louisiana Professional Engineering and Land Surveying Board issued disciplinary orders against an engineering and consultant firm frequently used by the plaintiff's bar.

Annihilated AOB

The Monson Law Firm coordinated a meeting with Louisiana Insurance Commissioner Jim Donelon to address a response to the assignment of benefits crisis. After this meeting the Louisiana Department of Insurance approved our new anti-assignment language in three days, protecting our clients from AOB abuse.


